

**Century West Neighborhood Association  
Meeting Minutes  
July 11, 2005**

Judy McKrell made the motion to open the meeting; motion seconded by Jason Moyer.

Board Members present: Judy McKrell, Bob Brell, Denise Gorman, Jeff England and Jason Moyer. Board Members absent: Jack Lewis and Bill Padgham. Diane Ross, Development Coordinator, Bend Neighborhood Associations Neighborhood Coordinator also attended.

Allison Randell attended the meeting to review the CWNA purpose and functions. Ms. Randell is a property owner in the CWNA area.

**Review of June 15, 2005 Board Meeting Minutes**

Jason Moyer moved to approve as is. Jeff England seconded. Motion passed.

**Iron Turf in City of Bend Medians, and other Median/Roundabout Treatments**

Jeff England spoke with Diane Crampton, Vice-Chair, Southwest Bend Neighborhood Association and Committee Chairperson, about participating in a newly formed citizens committee to study and discuss alternative median surface treatments for COB medians. Jeff England accepted the committee member role and will be meeting with Diane Crampton and her committee on Monday, July 18th.

**“Lets Pull Together”- City Wide Weed Pull Results.**

Bob Brell gave a report on the “low-turnout event”, mentioning that he and his wife, Dellie, along with Bill Padgham were three of only ten volunteers that met at the site/event. Discussion was brought up about better ways to improve turnout in future weed-pull events. Bob Brell commended the Orchard District Neighborhood Association for their organization of the post- weed pull event at Drake Park.

**Mt. Washington/Century Drive Roundabout Safety Status**

Jeff England reported on a conversation with Deborah Hogan, with the City of Bend Engineering Department about the safety issue at the Century Drive/Mt. Washington Drive roundabout. The planned meeting did not take place and Jeff England was told the issue was tabled for now and would be put back on the agenda with a focus on improving the safety in-and-around this roundabout. Jeff England was told the issue of safety for the Middle School children crossing Century Drive south of the roundabout would be handled in the bigger roundabout picture.

Bob Brell suggested we move forward and get our CWNA recognized by the City of Bend on July 20, 2005 first and then have a special CWNA meeting that focuses on this ongoing issue. All other board members agreed and a future meeting will be planned, suggesting that the start of the next school session would be a good time when parents and neighbors are best concerned.

**Bite of Bend & SummerFest Booth Results**

We received from Diane Ross, seven new membership applications from the Bite of Bend, and eleven membership applications from the Summer Fest. Diane Ross also noted the great feedback from all areas, excellent turnout at the booths, and excellent turnout of volunteers helping man the booths.

Diane Ross also presented the list of volunteers for both events. Jason Moyer was our only CWNA member to volunteer at the Bite of Bend. No CWNA members volunteered for the SummerFest.

A booth at Bend’s Fall Festival, October 1 and 2 is planned. More information will be available soon.

**Recognition of CWNA by the City of Bend on 7/20**

Bob Brell and Diane Ross announced that CWNA would become official on Wednesday, July 20, when recognized by Mayor Friedman and Council Members at the beginning of the planned city council meeting. All board members are asked to be there.

### **CWNA Signage**

Board members reviewed location options developed by Bob Brell and plotted on a map by Denise Gorman. A vote was taken and #1, (on Reed Market Road on the west side of the Bill Healey Bridge), and #2, (on Century Drive the south side of the Century Drive/Simpson Avenue roundabout) received the majority support from the CWNA Board.

### **CWNA Membership Campaign Status**

Judy McKrell reviewed her growing relationship with certain homeowners associations and her concerns of what needs to be addressed for continued growth and better communication with other neighborhoods. Denise Gorman and Judy will team up to create a brochure/mailer to assist in her membership campaign. It will also include an application.

Bob Brell will add to the next board meeting's agenda the review of the brochure.
